- Treasurer's Report: Treasurer, Jenny Kilgore, provided a summary of current balance and expenditures in FSCSWO account. Current checking account balance is \$5, 717.21; with CD's, ending balance totals to \$26,512.72.

- •Hamilton County Public Health (HCPH) contacted HCP+D to inquire if FSCSWO would be interested in partnering for a research grant. HCPH is receiving funding through a Maternity and Child Health Grant, which includes conducting a physical and nutritional health assessment within identified communities. HCPH staff determined it would be most efficient to complete the study in communities within an existing consortium or connection of communities. FSCSWO executive committee discussed and came to consensus it would benefit FSCSWO communities to collaborate with HCPH for this study. S. Todd will invite HCPH staff to February Executive Committee meeting to further discuss and agree on chosen communities for the study. FSCSWO will consider inviting jurisdiction representatives to the meeting, as well. The grant is aiming to



address needs within communities which have a high percentage of disadvantaged residents, so this will be considered in choosing FSC communities.
