- Welcome and introductions facilitated by Mayor Dan Pillow of Addyson, Chair of First Suburbs Consortium of Southwest Ohio. A special welcome to Denise Driehaus, Hamilton County Commissioner; Jonathon Dever, Ohio State Rep District 28; Dusty Rhodes, Hamilton County Auditor; guest speakers Kelly Harrington, Tracy Roblero and Joy Pierson; and many elected officials, administration and business partners from Hamilton County jurisdictions totaling about 60 guests.
- Treasurer's Report: FSC-SWO has a checking balance of \$6, 646.21 and a CD balance of \$27,766.76. To date, 14 jurisdictions have paid membership dues. Receiving dues allows FSC-SWO to put on membership meetings like this evening's event.
- Election of Executive Committee Officers- motions were made and seconded to keep Mayor Dan Pillow as Chair, Mayor John Smith as Vice Chair and Jenny Kilgore as Treasurer.
- Tom Moeller, Village Administrator of Madeira, gave an update on the MSD Affordability Task Force. The Task Force created a list of recommendations and has submitted them to the Hamilton County Board of County Commissioners (BOCC). See attached document.
- Housing presentations: Three guest speakers presented on housing related projects in their jurisdictions and potential funding through the county.
 - •Kelly Harrington from the City of Blue Ash gave a PowerPoint presentation on the CRA located near the "downtown" business corridor of Blue Ash. See attached PowerPoint presentation.
 - •Tracy Roblero discussed the decision to make housing a focus goal of the City of Montgomery's 2016 Strategic Plan:



"Goal 4: Montgomery will retain and attract quality and diverse housing options while maintaining a small town feel and effectively managing the infrastructure impacts of redevelopment.

Strategy 1: Create a housing strategy based on changing housing demands and the market and include input from residents, builders, Planning Commission and City Council.

Strategy 2: Identify tools to encourage the diversification of housing stock based on the Housing Strategy.

Strategy 3: Review and update the Comprehensive Plan and Zoning Code based upon the housing strategy.

Strategy 4: Review policies to mitigate the physical impacts of infill development and evaluate changes in the fabric of neighborhoods resulting from infill development.

Strategy 5: Identify new tools, policies and procedures to mitigate the impacts of single family infill development."
